Promotional Period: October 3, 2018 through March 5, 2019**

- 1. CONTEST RULES.** These rules govern the Office of Lottery and Charitable Games (“DC Lottery”) Washington Capitals® 2018 Stanley Cup® Champions Scratchers 2nd Chance Contest (“Contest”). By entering the Contest or by accepting a prize awarded through this Contest, each Contestant and Winner agrees to be bound by these rules. This Contest is conducted by the DC Lottery. The National Hockey League (“NHL”), its member clubs, affiliates and/or related entities (collectively, the “NHL Entities”), Lincoln Holdings LLC dba Monumental Sports & Entertainment, the Washington Capitals and Lincoln Hockey LLC and as owner of the Washington Capitals are not sponsors of this promotion and are in no way responsible for administering this Contest.
- 2. ELIGIBLE ENTRIES.** Contestants must be eighteen (18) years of age or older to participate in the Contest. Officers and employees of the DC Lottery, the NHL Entities, and their relatives living in the same household, DC Lottery contractors, vendors, and other persons who are otherwise disqualified, are not eligible for entry into this Contest. Tickets that have been discarded by the original purchaser are not eligible for entry into this Contest. Each entry must be completed on www.dclottery.com or on the official DC Lottery Second Chance Drawing Website. Each entry must include all required Contestant information including, but not limited to, Contestant's name, address, email address, and phone number, as well as the required code from a Washington Capitals® 2018 Stanley Cup® Champions Scratchers ticket (“Qualifying Ticket”). Entries received after the Entry Submission Deadline (defined below) will not be eligible for entry into the Contest. Contestants must make a qualified purchase in order to claim a prize. Entries must meet all eligibility requirements. Entries that are incomplete, garbled, corrupted, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion (including, without limitation, at the DC Lottery's or any other entity's servers), are not eligible for entry into this Contest. Eligible Contestants may enter multiple times, subject to the entry requirements.
- 3. HOW TO ENTER.** Each Qualifying Ticket will bear a ten (10) digit code. The ten (10) digit code is located underneath the scratch-off material on the bottom of the ticket. During the promotion (October 3, 2018 through March 5, 2019) (“Promotional Period”), Contestants can use the ten (10) digit code to enter the Contest. Contestants receive one (1) entry for each Qualifying Ticket. Contestants enter the Contest by going to

www.dclottery.com or to the official DC Lottery Second Chance Drawing Website and entering all required Contestant information, including the required ten (10) digit code from a Qualifying Ticket. All entries must be received by the DC Lottery before the Entry Submission Deadline dates and times stated below. Contestants are not required to save their Qualifying Tickets once they are entered into the Contest.

4. **DRAWINGS AND PRIZES.** Prizes are non-transferable, non-refundable, have no cash value and must be accepted as awarded. The entry submission start dates, entry submission deadlines, drawing dates, and prizes for the Contest are contained in the following chart:

**Eligible Entries are only valid for the next drawing that occurs after entry into the Contest, except that all Eligible Entries will be included in the final Grand Prize drawing for the On-Ice Challenge Experience.*

(1) Capitals Away Trip Prize Package includes the following: Roundtrip (coach airfare) for two (2) to Las Vegas, NV, McCarran International Airport (Airport); hotel accommodations for two (2) nights (double occupancy) at the Capitals team hotel (Hotel); meals (alcohol not included); two (2) tickets to the Washington Capitals versus the Vegas Golden Knights hockey game scheduled to occur on December 4, 2018; ground transfer between the Airport and the Hotel; ground transportation between the Hotel and the hockey game; a Washington Capitals replica jersey signed by the 2018-2019 Capitals roster; and a hat signed by signed by the 2018-2019 Capitals roster. The total prize package value is approximately \$3,100 (less applicable taxes and withholdings).

(2) Capital for a Day Experience Prize Package includes the following: Five (5) Monumental Sports & Entertainment Corporate Partnerships Suite tickets to the Washington Capitals vs. Philadelphia Flyers hockey game scheduled to occur at Capital One Arena on January 8, 2019; an opportunity for the winner and a guest to participate in the Pre-Game Fan Tunnel as the team comes out of the locker room onto the ice; an opportunity for the winner and a guest to be near the ice while team warms up; food and beverages (alcohol not included) at the hockey game; a Washington Capitals replica jersey signed by the 2018-2019 Capitals roster; and a hat signed by the 2018-2019 Capitals roster. The total prize package value is approximately \$3,300 (less applicable taxes and withholdings).

(3) Five (5) Hockey Game Tickets Prize Package includes the following: Five (5) Monumental Sports & Entertainment Corporate Partnerships Suite tickets to the Washington Capitals vs. Los Angeles Kings hockey game scheduled to occur at Capital One Arena on February 11, 2019; food and beverages (alcohol not included) at the hockey game; a Washington Capitals replica jersey signed by the 2018-2019 Capitals roster; and hat signed by the 2018-2019 Capitals roster. The total prize package value is approximately \$2,350 (less applicable taxes and withholdings).

(4) NHL Awards™ Trip Prize Package includes the following: Roundtrip (coach airfare) for two (2) to Las Vegas, NV, McCarran International Airport (Airport); hotel accommodations for two (2) nights (double occupancy); meals (alcohol not included); two (2) tickets to the NHL Awards™ scheduled to occur in June 2019; ground transfer between the Airport and the Hotel; and ground transportation between the Hotel and the awards show. The location of the NHL Awards™ is subject to change by the NHL. The total prize package value is approximately \$2,500 (less applicable taxes and withholdings).

(5) On-Ice Challenge Experience Prize Package includes the following: Two (2) Monumental Sports & Entertainment Corporate Partnerships Suite tickets to the Washington Capitals vs. Montreal Canadiens® hockey game scheduled to occur on April 4, 2019; food and beverages (alcohol not included) at the hockey game; and one (1) Washington Capitals replica jersey . The Winner will participate in the On-Ice Challenge Experience during intermission for an opportunity to win up to \$50,000 with a guaranteed minimum prize of \$25,000. The total prize package value is approximately \$950 plus the amount won during the On-Ice Challenge (less applicable taxes and withholdings). The prizing has no cash options. A proxy may participate in the On-Ice Challenge on behalf of the Contestant if the Contestant is not available or cannot participate because of a disability.

The proxy will not receive any of the prize money that is won, nor will the prize be paid to the proxy. All On-Ice Challenge proxies must complete an On-Ice Challenge Proxy Form before April 4, 2019.

5. **SELECTION OF POTENTIAL WINNERS.** The first Eligible Entry drawn in each drawing shall be the Potential Winner of the prize package for that drawing. If the prize is not claimed by the Potential Winner by the stated deadline, the prize will be forfeited.
6. **PRIZE NOTIFICATION, CLAIMS, AND FORFEITURE.**
 - A. **Potential Winners.** Official notification from the DC Lottery to Potential Winners will be sent within five (5) days of the Drawing Date by tracked US Mail sent to the mailing address provided by the Contestant when entering the Contest and by email sent to the email address provided by the Contestant when entering the Contest. Contestants are solely responsible for providing their correct mailing address and email address when entering the Contest. **Potential Winners must claim their prize within fourteen (14) days from the date of the Winner Notification Letter at the DC Lottery Prize Center located at 2235 Shannon Place, SE, Washington DC 20020.** All required forms must be submitted when claiming the prize. Potential Winners that fail to claim their prize as instructed within the fourteen (14) day time limit will be disqualified and the prize will be forfeited.
 - B. **Winner Notification Letters and Acceptable Forms of ID.** Winner Notification Letters include a copy of these Official Contest Rules and information about how to claim the prize. The Prize Center will provide an Acceptance and Release Form that must be fully completed and signed in order to claim the prize. Potential Winners must present two (2) forms of identification in order to claim a prize. Acceptable forms of identification include: (a) a valid state issued Driver's License, or state-issued Non-Driver's License, or a valid U.S. Passport and (b) an original Social Security card. The name used when entering the Contest must match the name on the identification presented when claiming a prize. Prizes must be claimed in person at the DC Lottery Prize Center located at 2235 Shannon Place, SE, Washington, DC 20020. Each prize winner must be at least eighteen (18) years of age or older in order to receive the prize. Failure to provide acceptable identification may result in disqualification and forfeiture of the prize.
 - C. **Drawing Results.** Drawing results will be posted on www.dclottery.com within ten (10) business days from the date of the Drawing.
7. **INDEMNITY AND RELEASE.** By entering the Contest or by accepting a prize awarded through this Contest, each Contestant and winner agrees to release, indemnify, and hold harmless the Government of the District of Columbia, the DC Lottery, the NHL Entities, Lincoln Holdings LLC dba Monumental Sports & Entertainment, the Washington Capitals and Lincoln Hockey LLC and as owner of the Washington Capitals, and their respective officers, employees, agents, representatives, co-promoters, advertising agencies and

contractors ("Contest Entities") from liability for any claims arising out of, or related to this Contest.

8. **ACCEPTANCE AND RELEASE FORM.** Potential Winners, proxies and their guests must sign the DC Lottery's Acceptance and Release Form. The Acceptance and Release Form confirms the Potential Winner's compliance with these Official Contest Rules and other requirements. In addition, by signing the Acceptance and Release form, Potential Winners authorize the DC Lottery, without any further consideration, to use the Potential Winner's likeness and name, and the Potential Winner's city, county, and state of residence for advertising, reporting, and promotional purposes in any print, broadcast, electronic, internet, or other form or media whatsoever. Potential Winners also release the Contest Entities and their representatives from liability of any kind and from any claims arising out of this Contest or prizes awarded.
9. **PRIZES AND OTHER RESTRICTIONS.** Odds of winning any prize depend on the number of entries received for each drawing. The DC Lottery reserves the right to substitute prizes. A prize is not transferable once the winner has claimed. Winnings valued at more than \$600 will be reported to federal, state and District tax agencies.
10. **LIMITATION OF LIABILITY.** All decisions regarding the Contest including, without limitation, winner selection, disposition of a prize, payment of taxes, selection of alternates, photograph suitability for public display, application and interpretation of the Official Contest Rules, resolution of any dispute or Contest eligibility shall rest solely with the Executive Director of the DC Lottery ("Executive Director") or the Executive Director's designee and shall not be subject to appeal. The Executive Director may change the date, time and location of Drawings. The Contest is subject to cancellation at any time. The Executive Director reserves the right to change and supersede any outlined procedures or rules to handle unforeseen circumstances. The Contest Entities are not responsible or liable for entries or notifications and required documents that are not otherwise in compliance with these Official Contest Rules, whether caused by any of the equipment or programming associated with or utilized in the Contest, or by any technical or human error which may occur in the processing of Eligible Entries into the Contest, or for failure to receive Eligible Entries due to transmission failures or technical failures of any kind and such noncompliant entries will be disqualified. By entering the Contest, each Contestant irrevocably agrees and acknowledges to be bound by the Official Contest Rules and all applicable laws, and decisions of the DC Lottery; to forever and irrevocably waive all of his/her rights to claim ambiguity with respect to the Official Contest Rules; and to forever and irrevocably release, indemnify, and hold harmless the Contest Entities and their respective subsidiaries, affiliates, officers, directors, employees, agents, representatives, successors and assigns (collectively the "Releasees"), from any liability, (including, but not limited to, liability for defamation, libel, slander, invasion of privacy, infringement of publicity or any intellectual property rights, any property loss, damage, personal injury, bodily injury, death, expense, accident, delay, inconvenience or irregularity, and any indirect, incidental, consequential, special, punitive or exemplary damages of any kind even if the Releasees have been advised of the possibility of such loss or damages), costs and expenses (including, without limitation, reasonable outside attorneys' fees) that may arise from, result from or are in

connection with: (a) the Contest, including but not limited to any Contest-related activity or element thereof, and the Contestant's Eligible Entry(s), participation or inability to participate in the Contest, (b) the violation of any privacy, personal, publicity or proprietary rights, (c) typographical errors in these Official Contest Rules or any Contest promotional materials, (d) acceptance, attendance at, participation in, possession, defects in, use, misuse or inability to use the prize (or any component thereof), (e) any change in the prizing (or any components thereof) due to unavailability, business or creative considerations, or due to reasons beyond the DC Lottery's control, including but not limited to by reason of any acts of God, any action(s), regulation(s), order(s), or request(s) by any governmental or quasi-governmental entity (whether or not such action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, threatened or actual terrorist acts, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any other cause beyond any of the Contest Entities' control, or as otherwise permitted in these Official Contest Rules, (f) any interruptions in or postponement, cancellation, or modification of the Contest, (g) human error, (h) incorrect or inaccurate transcription, receipt or transmission of any part of the Contest Entry (including, without limitation, the Entry Information or any parts thereof), (i) any system, computer timing and/or dating mechanism, computer equipment, software, or Internet service provider utilized by any of the Contest Entities or by a Contestant, (j) interruption or inability to access the Contest, the Website or any other Contest-related web pages, or any online service via the Internet due to hardware or software compatibility problems, (k) any damage to Contestant's (or any third person's) computer and/or its contents related to or resulting from any part of the Contest, (l) any lost/delayed data transmissions, omissions, interruptions, defects, or any other destroyed, incomplete, undeliverable or damaged Contest Entries, (m) any wrongful, negligent, or unauthorized act or omission on the part of any of the Contest Entities, or any of their agents or employees, (n) any wrongful, negligent, or unauthorized act of omission on the part of a prize supplier or any of its agents, servants, employees or independent contractors, (o) lost, late, stolen, misdirected, damaged or destroyed prizing (or any element thereof), (p) or any other cause, condition, or event whatsoever beyond the control of Contest Entities or their parents, subsidiaries, and affiliated companies. Each Contestant hereby acknowledges that the Contest Entities have neither made nor are in any manner responsible or liable for any express or implied warranty, representation or guarantee, express or implied, in fact, or in law, relative to the prize or any component thereof.

11. **GOVERNING LAW AND VENUE.** This Contest shall be governed and construed in accordance with the laws and regulations of the District of Columbia. Venue shall be in an appropriate court of jurisdiction located in the District of Columbia.
12. **ENTRIES TO REMAIN THE PROPERTY OF THE DC LOTTERY.** All entries shall remain the property of DC Lottery and may be destroyed. No entries will be returned to Contestants.
